#### **Re: Appendix 4C - Quarterly Report**

Please refer to the 'Appendix 4C' attached for details for the period ended 31 March 2012 for the Group.

During the quarter the Company completed a placement to strengthen the overall cash position, which will be bolstered further by the recent Rights Issue.

The overall cash consumption for the quarter was \$854,000 down from \$1,249,000 from the previous quarter.

The majority of the expenditure in the quarter is attributed to the Companies research and development activities and to the regulatory filing & manufacturing costs associated with seeking marketing approval and commercial launch for CardioCel – the cardiovascular tissue patch to treat heart defects caused by congenital heart disease.

The Allied Medical Sales & Marketing business continued to generate significant sales and Coridon continues to progress its vaccine programs, in particular the herpes vaccine towards a Phase I clinical study.

Over the quarter the company has had a number of ASX and press releases supporting the progress being made within the Allied Healthcare Group, which can be viewed on the Company's website <u>www.alliedhealthcaregroup.com.au</u>.

Allied Healthcare Group anticipates continued progress from the companies within the group in the coming quarter and for the rest of 2012.
