NON-EXECUTIVE DIRECTOR APPOINTMENTS

Mr Donald James Argent BCom, CPA, FCIS, FAICD

Mr Argent was the Director Finance and Administration for the Thiess Group, one of the largest integrated engineering and service providers in Australia and South East Asia. Mr Connelly holds a Bachelor of Business degree and has held various senior management positions for a number of resource companies, including five years with Adamus Resources, five years with Newmont Mining Corporation, USA and 12 years with Inmet Mining Corporation, Canada.

Mr Connelly has extensive experience with the development and operation of mining projects for a variety of commodities, including gold, base metals and other resources in Australia, Canada, USA, West Africa, South America and Europe. Mr Connelly will be able to provide useful insights into how Ausdrill might improve the services it provides to meet the particular needs of offshore mining companies.
