# ISSUE OF ENTITLEMENT OFFER SHARES AND TOP 20 SHAREHOLDERS

**Iron Road Limited (Iron Road**, ASX: **IRD**) is pleased to announce the issue of 47,617,382 fully paid ordinary shares (**New Shares**) today to shareholders who applied to take up their entitlement and made valid applications to the Shortfall Facility under the 1 for 9 non-renounceable pro-rata entitlement offer announced by Iron Road on Thursday, 16 June 2016 (**Entitlement Offer**).

Retail demand for additional shares via the Shortfall Facility was strong. Applications for an additional 580,244 Shortfall Shares were scaled back in order to comply with the 50% Shortfall Cap stipulated in the Entitlement Offer. The scale back of these invalid applications for Shortfall Shares exceeded the total number of valid Shortfall Shares allotted. Related Parties of Iron Road were not entitled to submit applications under the Shortfall Facility.

The New Shares will commence ordinary trading on ASX tomorrow, Tuesday, 12 July 2016 and will rank equally with all other fully paid ordinary shares of Iron Road.

The number of Iron Road shares on issue prior to the issue of the New Shares was 592,454,904. Following the issue, the number of Iron Road shares on issue is 640,072,286.

Iron Road confirms that the dispatch of holding statements in respect of the New Shares will be completed today.
