## EXERCISE OF UNLISTED OPTIONS - NOTICE IN ACCORDANCE WITH SECTION 708(A) OF THE CORPORATIONS ACT 2001 (Cth)

Sandfire Resources NL (ASX: SFR, or the Company) advises that 110,000 new fully paid ordinary shares (New Shares) have been allotted and issued upon the exercise of unlisted options. A completed Appendix 3B in respect of the New Shares is attached.

### **Secondary Trading Exemption Notice**
