VESTING AND LAPSE OF PERFORMANCE RIGHTS AND ISSUE OF ORDINARY SHARES - NOTICE IN ACCORDANCE WITH SECTION 708(A) OF THE **CORPORATIONS ACT 2001 (Cth)**

Vesting of Performance Rights

- 161,106 FY2015 Performance Rights granted under the LTI Plan have vested where performance conditions were met during the performance period 1 July 2015 to 30 June 2017.
- 161,106 fully paid ordinary shares (New Shares) have been allotted and issued to senior executives in accordance with terms of the LTI Plan. 84,944 of the New Shares were issued to the Managing Director. The remainder of the New Shares were issued to other eligible employees.

Lapse of Performance Rights

77,566 FY2015 Performance Rights granted under the LTI Plan lapsed where performance conditions were not fulfilled during the performance period 1 July 2015 to 30 June 2017.
