NOTICE GIVEN UNDER SECTION 708A(5) OF THE CORPORATION ACT

Talisman Mining Ltd issued 3,010,714 ordinary fully paid shares at 14 cents per share and 1,003,567 quoted options, exercisable at 20 cents expiring 31 December 2010, for nil consideration as part of the Share Placement announced on 17 May 2007.
