WONMUNNA – RECONNAISSANCE DRILL RESULTS

Results from a further 3 drillholes of the reconnaissance drilling program at the NMM (Northern Marra Mamba) prospect have been received with significant (CID - >40% Fe; Marra Mamba - >50% Fe) detailed in Table 1 below. Drillhole locations are shown on Figure 1.


