
WONMUNNA RECONNAISSANCE DRILL RESULTS

Results from a further 6 reconnaissance drillholes in the NMM prospect have been received with significant intercepts (>50% Fe) detailed in Table 1 below. (*Note: The Company has routinely reported all CID drill intercepts >40% Fe. However, as the project matures and resource drilling commences, only grades >50% Fe (regardless of the type of mineralisation) will henceforth be reported).*

Drillhole locations are indicated on Figure 1.
