INITIAL DRILL RESULTS FROM SMM PROSPECT, WONMUNNA, CONFIRM STRONG POTENTIAL FOR A SUBSTANTIAL IRON RESOURCE

Assay results have been received for the first 7 drillholes at the SMM (South Marra Mamba) prospect, Wonmunna Project, East Pilbara, with intercepts to **28m** @ **56.49% Fe** (Including **10m** @ **60.63% Fe**). Six of the seven drillholes reported significant (>50% iron) drill intercepts. Significant drill intercepts are listed in Table 1 and drillhole locations are shown on Figure 1.

Initial evaluation drilling at SMM is in the process of being completed on a 400m x 100m grid over this large area of concealed Marra Mamba Iron Formation. Complete results of this first pass drill evaluation are expected by end July, 2008.
