## **WONMUNNA: SILVER - COPPER - ZINC MINERALISATION INTERSECTED**

During reconnaissance Reverse circulation drilling at EMM, although no significant iron was intersected, the majority of the completed holes terminated in sulphidic black shales of the Jeerinah Formation (Figure 1). These intervals were therefore submitted for assay. Significant drill results are listed in Table 1.


