WONMUNNA IRON ORE – DRILLING UPDATE

Assay results have been received for a further 10reverse circulation drillholes completed as part of the program of gridded resource drilling at the NMM (North Marra Mamba) prospect, Wonmunna project, East Pilbara region, Western Australia. Significant (>50% Fe) drill intercepts are listed in Table 1 and drillhole locations shown on Figure 1.
