## **WONMUNNA IRON PROJECT - DRILLING UPDATE**

**Drill Intercepts at NMM to:** 

44m @ 56.31% Fe (including 18m @ 61.36% Fe), 33m @ 58.17% Fe (including 16m @ 61.30% Fe), 44m @ 59.30% Fe (including 30m @ 61.07% Fe), 28m @ 59.60% Fe (including 18m @ 60.03% Fe).

## **NMM Resource Drilling**

Assay results have been received for a further 19 reverse circulation drillholes completed as part of the program of gridded resource drilling at the NMM (North Marra Mamba) prospect, Wonmunna project, East Pilbara region, Western Australia. Significant (>50% Fe) drill intercepts are listed in Table 1 and drillhole locations shown on Figure 1.
