WONMUNNA IRON ORE – CMM DRILLING UPDATE

***High-grade iron mineralisation at CMM Prospect confirmed
Drill intercepts to 34m @ 57.7% Fe (incl. 8m @ 61.15% Fe)***

CMM RESOURCE DRILLING UPDATE

Assay results have been received for a further 12 reverse circulation drillholes completed as part of the program of gridded resource drilling at the CMM (Central Marra Mamba) prospect, Wonmunna project, East Pilbara region, Western Australia. Significant (>50% Fe) assay results are listed in Table 1 and drillhole locations shown on Figure 1.



These drill results continue to confirm the strong, thick, Marra Mamba – hosted iron mineralisation at the CMM prospect.

The Company remains confident that the CMM prospect will add significant resources to the Wonmunnna project, and significantly enhance the commercial viability of the project.

Receipt of assay results remains on schedule for determination of an initial JORC resource for the prospect by end November, 2008.
