RESULTS OF ANNUAL GENERAL MEETING

In accordance with Listing Rule 3.13.12, the Company advises that its 2018 Annual General Meeting was held today, 29 November 2018. Resolutions 1-7, put to the meeting, were passed on a poll. Resolution 8, being a special resolution, was not passed. The Company notes that while Resolution 1 (Adoption of Remuneration Report) was passed, more than 25% of votes cast on Resolution 1 were against it. As a result, this constitutes a first strike for the purposes of Division 9 of Part 2G.2 of the Corporations Act.
