Appendix 3B - Employee Share Plan

Western Areas Limited attaches an appendix 3B for the issue of 43,927 Fully Paid Ordinary Shares (Shares) under the terms and conditions of the Western Areas Employee Share Plan (Plan). The Plan allows eligible employees to acquire up to A\$1,000 of Western Areas Shares for nil consideration. Directors and Senior Executives are not eligible to participate in the Plan.

The Plan has been implemented to facilitate and encourage all employees to become owners in the business via direct shareholding. This is believed to bond and align employee efforts with positive outcomes for all the shareholders in the Company.

The number of Shares issued to each eligible employee is 403 Shares. This was calculated with reference to the 5 day volume weighted average price up to and including 31 January 2017 which was \$2.48/share. While the employee remains employed by Western Areas, the shares will be restricted from trading for a period of 3 years.

The Appendix 3B further reflects the cancellation of 117,147 performance rights to individuals who have ceased employment with the Company.
