

SHARE PURCHASE PLAN EXTENSION

Pancontinental Oil & Gas NL (ASX: PCL) wishes to advise that the closing date for its Share Purchase Plan (SPP) has been extended by one week to 29 January 2016 from the original closing date of 22 January 2016.

The Company has received a number of enquiries from shareholders in relation to the SPP offer. The one week extension to the original closing date of the SPP allows more adequate opportunity for the Company's shareholders to participate in the SPP.
