**REQUEST FOR TRANSITION FROM TRADING HALT TO VOLUNTARY SUSPENSION –  
 STRIKE RESOURCES LIMITED (ASX:SRK)**

We request a transition from the Company’s request for a trading halt (dated 12 December 2016) to a request for a voluntary suspension, in relation to the Company’s listed shares, pending the release of a market announcement.

The following information is provided in relation to this voluntary suspension request pursuant to Listing Rule 17.2:

(1) Reasons for the voluntary suspension	Pending the release of a market announcement in relation to the potential disposal of the Company’s interests in the <a href="#">Apurimac Magnetite Iron Ore Project</a> and <a href="#">CUSCO Magnetite Iron Ore Project</a> in Peru.
(2) Length of voluntary suspension	Until such time as the market announcement referred to in (1) is released on ASX. At this stage, this is expected to be within the next week (subject to consultation with ASX).
(3) Events expected to happen to end the voluntary suspension	Upon the release of a market announcement in relation to the matter referred to in (1).
(4) Reasons why the voluntary suspension should not be granted	The Company is unaware of any reasons why a voluntary suspension should not be granted.
(5) Any other information necessary to inform the market about the voluntary suspension	The Company does not have any other information necessary to inform the market about the voluntary suspension, pending the release of a market announcement referred to in (1).
